


#### <u>Training – K-9</u>

#### **Incidents of Special Interest**

On 07/14/2024 at 1:28am. Hamden Police responded to Dolan & Luzzi (1337 Dixwell Ave.) due to a shots fired complaint. A crime scene was formed and several spent cartridge casings were located. A short time later, a male victim from Brooklyn, NY arrived at St. Raphael suffering from a gunshot wound to his left hip and was later transported to Yale New Haven Hospital (YNHH). The victim stated that he was sitting on the patio area at the front of Charlie and James Place (1350 Dixwell Ave.) when he heard a gunshot. The victim said he stood up and felt the impact of a projectile to his left hip. The victim's injury was not life-threatening.

On 07/17/2024 at 6:08am, Officers McLaughlin and Bonds responded to the area of Franklin/Quaker Rd on the report of two males stealing from area vehicles. Upon arrival in the area, a juvenile from New Haven was immediately stopped and detained. The other suspect; Kevin Joyner 1/30/2006 of 50 Dayton St, New Haven fled from Officers on foot. During a search of the area, Ofc McLaughlin located Joyner hiding in the rear yard of a Fenway St residence. Joyner began throwing items into an adjacent yard before he was taken into custody. It was determined both subjects were stealing from local vehicles. Joyner was also found to be in possession of a Taser and burglary tools. The juvenile was issued a juvenile summons and returned to his residence. Joyner was held on bond on larceny, burglary, and weapons charges. Ofc McLaughlin conducted the initial investigation.

On 7/24/24 at approximately 09:07am there was a larceny/purse snatching in the Stop and Shop parking lot (2335 Dixwell Ave). The 78 year old victim was walking with her wallet under her arm when an unidentified male wearing a mask ran up from behind and took her wallet from under her arm. The wallet contained \$500 in cash. The unidentified subject then got back into the passenger side of a white Acura SUV bearing CT Reg AP79425 and fled. The vehicle is stolen out of Milford. At approximately 1000am, a similar incident with the same vehicle occurred at Target in North Haven. The investigation is being conducted by the Major Crimes unit and is ongoing.

#### New Haven Gang Member Admits Role in Murder

QUAYMAR SUGGS, 20, of New Haven, pleaded guilty yesterday before U.S. District Judge Victor A. Bolden in New Haven to a racketeering offense related to his participation in a violent New Haven street gang and the murder of an associate of a rival gang in May 2021.

Today's announcement was made by Vanessa Roberts Ävery, United States Attorney for the District of Connecticut; John P. Doyle, Jr., State's Attorney for the New Haven Judicial District; James Ferguson, Special Agent in Charge, ATF Boston Field Division; Robert Fuller, Special Agent in Charge of the New Haven Division of the Federal Bureau of Investigation; Stephen Belleau, Acting Special Agent in Charge of the Drug Enforcement Administration for New England; and New Haven Police Chief Karl Jacobson.

According to court documents and statements made in court, in an effort to address violence in New Haven, the ATF, FBI, DEA and New Haven Police Department, working closely with the U.S. Attorney's Office and New Haven State's Attorney's Office, have been investigating a gang war between members and associates of the Exit 8 street gang and rival gangs in the Hill section and other areas of the city. The Exit 8 gang is named after the geographic area accessed by exiting Interstate 91 at Exit 8 in New Haven. Recently, younger members of Exit 8 are identifying themselves with the word "Honcho," which is derived from the street name of an Exit 8 member who was murdered on Quinnipiac Avenue in February 2020.





The investigation revealed that Suggs and other members of the Exit 8 gang engaged in drug trafficking, used and shared firearms, and, since June 2018, have committed at least three murders and 16 attempted murders. Exit 8 members and associates also stole vehicles, at times from outside of the state, and used those stolen vehicles when committing acts of violence. Gang members also promoted, coordinated, facilitated, and celebrated their narcotics distribution and acts of violence through text messaging and the use of social media applications and websites including Facebook, Instagram, Snapchat, and YouTube.

Suggs pleaded guilty to conspiracy to engage in a pattern of racketeering activity, including acts of violence, narcotics trafficking, and gun sales, and specifically admitted that, on May 19, 2021, he shot and killed an associate of a rival gang. Suggs also admitted that in 2021, he and other Exit 8 members broke into a Connecticut state trooper's car and stole the trooper's duty bag.

At sentencing, which is not scheduled, Suggs faces a maximum term of imprisonment of life. Suggs has been detained since March 24, 2023.

This investigation is being conducted by ATF, the FBI, the DEA, the New Haven Police Department, the **Hamden Police Department**, and the New Haven State's Attorney's Office, with the assistance of the Connecticut State Police and the Connecticut Forensic Science Laboratory. The case is being prosecuted by Assistant U.S. Attorneys Tara E. Levens, Rahul Kale and Jocelyn C. Kaoutzanis.

This prosecution is a part of the Justice's Department's Project Safe Neighborhoods (PSN), Project Longevity and Organized Crime Drug Enforcement Task Forces (OCDETF) programs. PSN is a program bringing together all levels of law enforcement and the communities they serve to reduce violent crime and make neighborhoods safer for everyone.
