Hamden Police Applicant Card \$25.00 fee (Cash or Check) Payable to "Biometric Identification Services" Fingerprinting: The State no longer accepts money orders or bank checks to accompany fingerprints. You MUST pre-enroll to be fingerprinted and pay online via credit card only. The website to enroll is https://ct.flexcheck.us.idemia.io/cchrspreenroll/The service code for Hamden PD pawnbroker's license fingerprints is **153B-3837**. The fee is \$75.00. Once you are pre-enrolled to be fingerprinted you MUST bring a printed copy of the barcode/tracking number with you. If the barcode /tracking number does not accompany the fingerprints we will NOT be able to accept the application. Please note that once you complete the pre-enrollment process and pay online there are NO refunds.
